- You have access to 18 months of statements online. That means if you need a statement copy, you can print one yourself rather than requesting a copy from the credit union
- It's paperless which is good for the environment
- It's completely FREE!

To enroll in eStatements, you must be currently enrolled in Online Banking and have a valid email address. To enroll, login in to **Online Banking, select eStatements from the Documents Menu**, review and accept the agreement... it's that easy!
